RENTAL/PARTICIPATION AGREEMENT - RELEASE FROM LIABILITY
Please read carefully before signing

1. If applicable, I accept for use as is@ equipment rented by Roadrunner Paintball/KSA.
2. If applicable, I will be responsible for the replacement at full retail value of any equipment rented but not returned to Roadrunner Paintball/KSA.
3. Roadrunner Paintball/KSA conducts paintball games and other games using, among other things, marking pellets propelled by CO₂ POWERED MARKERS. I UNDERSTAND THAT THIS ACTIVITY AND TRANSPORTATION TO AND FROM IT, CAN BE HAZARDOUS AND INVOLVE RISKS THAT COULD RESULT IN PERSONAL INJURY, INCLUDING EYE INJURY OR EVEN DEATH, AS WELL AS DAMAGE TO OR LOSS OF PARTICIPANT. THIS IS CONDUCTED IN VARIABLE TERRAIN WHICH CAN INCLUDE ROCKS, TREES, STEEP INCLINES, STREAMS, FOXHOLES OR OTHER FEATURES WHICH CAN CAUSE ACCIDENT OR HARM TO MYSELF OR OTHERS.
4. I clearly understand the requirement and necessity that EYE GOGGLES provided by Roadrunner Paintball/KSA, be worn and kept firmly seated on the face at all times when on or near the field of play. These risks have been explained to me and I recognize, accept and assume them.

IN CONSIDERATION OF ROADRUNNER PAINTBALL/KSA PERMITTING ME TO PARTICIPATE IN THESE MARKING PELLET GAMES AND TO BE TRANSPORTED TO AND FROM THEM, I AGREE NOT TO SUE AND I HEREBY RELEASE ROADRUNNER PAINTBALL/KSA AND THEIR LESSORS, SHAREHOLDERS, OWNERS, OFFICERS, AGENTS, SERVANTS AND EMPLOYEES FROM ANY LIABILITY AND ALL CLAIMS FOR PERSONAL INJURY, DEATH, OR PROPERTY DAMAGES OR LOSSES SUSTAINED BY OR FOR MEDICAL EXPENSES ARISING FROM OR RELATED TO THE ABOVE ACTIVITY; EVEN IF THESE ARE CAUSED BY THE NEGLIGENCE, OR ANY OTHER TYPE OF CONDUCT, OF ANY OF THE AFORESAID ENTITIES AND PERSONS EITHER INDIVIDUALLY OR IN CONCERT WITH OTHER PARTIES.
